Family Camp Code of Conduct

In order to keep your family and other Ligonier Camp and Conference Center (LCCC) participants safe during your time here we ask your family to read and sign the following Code of Conduct. LCCC has high expectations for the conduct of participants in Family Camp. Although some participants may not fully agree with LCCC's mission, statement of faith, stances, and policies we ask that they respect them and adhere to the following while at camp.

- In order to protect LCCC program participants, volunteers, and staff, no adult should ever be alone with a single child who is not part of that adult's family in a place where the two cannot be readily observed by others.
- LCCC takes the abuse of children very seriously. All types of child abuse (physical, verbal, sexual, or mental) will not be tolerated. If you or a family member witness any such abuse while at camp please inform the leadership of LCCC immediately.
- 3. LCCC is an alcohol and illegal drug free facility. Possession of either is not permitted on LCCC property.
- 4. Smoking or use of tobacco by those under age 21 is prohibited at LCCC. Those 21 years of age or older may only smoke or use tobacco in designated areas. Please ask LCCC staff members if you need to know where those areas are located. This policy also applies to e-cigarettes and vaping.
- 5. Profanity, inappropriate jokes, and any kind of harassment is prohibited while participating in LCCC programs.
- We ask that all LCCC program participants adhere to all signage and instructions established by the camp's leadership for the purpose of protecting property, staff, and participants.
- 7. LCCC takes both the physical and emotional safety of families seriously. The camp not only meets the child abuse prevention standards of the state of Pennsylvania, but also views every person as created by God in his own image. Therefore we are fully committed to caring for every individual, regardless of background or belief, in accordance with Genesis 1.

- LCCC often runs more than one program at a time on the property. While attending family camp at LCCC we ask that you not interact with participants in or from other programs.
- Although many COVID-19 restrictions have been lifted, LCCC is still bound by guidelines
 established by the American Camping Association and the Centers for Disease Control
 (CDC). Therefore we ask that all families agree to the following:
 - a. Your family will need to have tested for Covid-19 within 72 hours of arriving at camp **IF ANY** of the following apply:
 - The CDC's Covid-19 Data Tracker indicates that community levels in your county are moderate (yellow) or high (red). Check the <u>CDC COVID Data Tracker</u> the Thursday before you arrive at camp.
 - A family member has come in contact with someone who has tested positive for Covid-19 within 7 days before "Incoming Day" of camp.
 - A family member has had symptoms of Covid-19 within 7 days prior to the start of camp.
 - Should you be required to test, please be prepared with proof of your negative results at check in (a phone photo is sufficient).
 - b. LCCC has taken enhanced measures for the health and safety of our campers and staff. Risk of exposure to Covid-19 exists in any public place where people are present. Covid-19 is an extremely contagious disease that can lead to severe illness and death. Senior citizens and people with underlying medical conditions are particularly vulnerable. By coming to LCCC you voluntarily assume all risks related to exposure to Covid-19.

By signing below you acknowledge you have read all the above guidelines and the assumption of risk statement, and to the best of your knowledge you have met, agree to, and will abide by all the requirements before attending. Failure to adhere to this code of conduct may result in expulsion from LCCC property and programs without refund.
